Bellis is a unique and authentic organization that celebrates people finding support, care and affirmation through sharing their stories and forming connections.

Our panel discussions with high school students, our retreats for birth parents and adoption social workers and our growing Evening of Adoption Connection meetings touch everyone in the adoption triad, including birth and adoptive grandparents. And our programs lift up the adoption experience with grace, humility and a recognition of both the beauty and heartbreak inherent in the decision to choose adoption.

We frequently hear that we fill gaps not addressed through other resources and offer support that reaches well past the legal adoption proceedings. We are here for the whole journey — from the birth parent who begins her search, to the new parents of a child recently adopted, all the way to the adults who were adopted and want to celebrate both their biological as well as forever families. Together, we bear witness, honor and affirm their experiences.

And, as adoption changes, we are preparing to support those changes, as well, including families built from foster-to-adopt and understanding the needs of parents whose rights have been terminated involuntarily.

This work is emotionally exhausting, but also deeply rewarding. We can't do it without you. To our volunteers, our staff, our program participants, our funders, our families and our cheerleaders — thank you. We are so grateful and humbled that you trust us with your stories and your hearts.

- Honor in all interactions, seeking to earn and nurture trust and respect.
- Vulnerability in relationships, acknowledging that growth comes through openness.
- An inviting approach in gatherings, believing that an accepting and nonjudgmental space is necessary to discuss adoption experiences.

COMMON CLASSROOM QUESTIONS REVEAL NEED FOR MORE EDUCATION

Even those who refer to themselves as "wallflowers" find themselves loving public speaking in high school classrooms with Bellis. Why? Teenagers are highly engaged listeners. Their astonishment at even the most basic facts about adoption shows the need to cast light on the topic.

In speaking with about 5,800 students in the past year, they told us some of the most surprising things they learned. Here is a sample of their verbatim comments:

- "I did not know that it could take so long to adopt a child."
- "They have extremely extensive checks on the families."
- "Saying 'put up for adoption' isn't the correct term."
- "Parents actually love their adopted kids like they are their own."
- "The adoptive parents and birth parents can become like family in some sort of way."
- "There's such thing as an open adoption, because I thought you're not supposed to have any contact at all."

• "There are 750 kids that need to be adopted from foster care. I'm just shocked about how many kids need to be adopted."

Bellis is on track to visit more than 50 schools, often multiple times each year. This is possible only because of about 80 speakers who speak in teams, providing dynamic presentations that are often among the students' favorite.

With few exceptions, the volunteer speakers take time off busy careers as physicians, engineers, managers, teachers, etc. With training and support, they share their personal stories of adoption and educate about modern adoption, including adoption from foster care, in general. A few months into the new school year, 81 percent of the students reported having a more positive understanding of adoption.

One student's message to our volunteers reflects the universal appeal of adoption stories: "I think they are really smart and brave. And I really admire that they considered all the possibilities and took the decision that worked best for themselves and their children."

SILENCE CAN SIGNAL A DEEPER CONNECTION

Under one roof with nearly 30 women, moments of silence catch us off guard at the Stronger Together weekend retreat for birth mothers. But silence — always fleeting — can mean the impact is so monumental that it takes a few days or weeks for the words to find their way out. Sometimes we have to sift through what the heck just happened in that quiet lodge up north before we're ready to explore why we feel so different after leaving.

When we returned back to reality, the voices of the once-quiet observers became louder, and they shared a similar message with Bellis — "I finally found my people!"

I was filled with so much love and joy. I was surrounded by a group of women, from all different backgrounds and with all different stories, but with one common bond. We were treated with respect, compassion and love. Bellis has changed my life. Without it I don't know where I would have gone or who I would have turned to. I knew I needed help and support, and Bellis was right there. There is no other birth mom support out there like this in our area and I am so grateful for all that they do.



The profound moments of the retreat are balanced with a healthy dose of goofiness. This year, scavenger hunt teams captured the friendships that begin during the weekend and continue in the year ahead.

As a birth mother with a closed adoption, I carried the guilt, shame and stigma of surrendering my child for 47 years before I was finally able to speak about my daughter. I had built a wall around me so that no one could see the loss and grief that I was carrying with me. Being a part of the last three Bellis birth mother retreats has had an incredible impact on my life. Meeting other birth moms, forging lasting friendships and knowing that someone else gets it. – Kristi Lalan

A place of real rest, warm open arms that embraced me from the moment I arrive. No judgement, no right or wrong answers, just get to be me and be loved on. Messy parts, confusion, hurt, lost and loved. Every moment of the retreat you feel supported and cared for in the ways we try to care for others. It is the only place in this world we don't have to explain what it means to be a birth mother and all the emotions that come along with that story. Thank you from the bottom of my heart for a space to remember and believe in the good. — Annie Meehan

Executive Director's Report WE'RE STRIVING TO LISTEN TO EVERY VOICE

All year long, we witness with awe the transformations that happen when people share their adoption stories with honesty — and welcome others' stories with acceptance. Bellis is so good at creating responsible, welcoming, brave spaces for these connections. But one question is always on my mind: Who is missing from the table?

To help us find out, we turned to Wilder Research. Through a complete literature review related to the experience of birth mothers, Wilder Research identified exactly what we see with our own eyes:

- Birth mothers often feel grief-stricken, anxious, and ashamed
- The grief associated with such a loss is not typically resolved easily or quickly, particularly due to its ambiguous nature, and may endure for years

Wilder Research could identify only a handful of other organizations across the country that offer varied levels of the types of services identified as beneficial, such as:

- Opportunities to share feelings and stories so that they feel understood and validated
- Peer support or other supports not connected with the agencies involved with their child's placement

In addition to providing those services and more, we are guided in our work by licensed professionals, and we have no affiliations with political or religious agendas, nor any child-placing service. This is what distinguishes Bellis.

Now, to the "who's missing" question. We asked Wilder Research to identify organizations that offer adoption-informed care to women who have lost custody of their children because of intervention by child protection services (e.g. foster care). Sadly, the answer was: no one. Bellis is so good at creating responsible, welcoming, brave spaces for these connections.

But one question is always on my mind: Who is missing from the table?

If Bellis expanded to offer peer-based support to combat shame and emotional isolation to individuals whose children have entered the foster care system, research indicates that we could provide the same benefits to this population as we achieve with most people we serve:

- · Improved ability to experience trust
- · Diminished sense of failure and powerlessness
- Improved capacity for productive lives


Bellis is doing good work, but there is much more good work to be done. As always, your support encourages us along the way as we strive to listen to every voice in the adoption community. Please stay tuned.

FINANCIALS

Bellis strives to comply with current standards for nonprofit management and reporting. While we still use a pie chart to show the percentages of each income source, we use a graphic, developed by Propel Nonprofits, that more completely tells the story of our expenditures. This graphic shows that a solid core at the center of our organization, in the form of fundraising and management, is essential to our mission and program successes. With a small staff, Bellis utilizes an outside bookkeeping firm to maintain internal control procedures. While the budget doesn't meet the threshold required for an annual audit, Wipfli's nonprofit group prepares our tax returns and ensures all state and federal reporting requirements are met.

Some highlights of our budget:

- By the end of our current fiscal year on June 30, 2020, we anticipate actual expenses will total \$119,467. On top of that, we have budgeted \$45,448 in in-kind services, which includes creative, printing and marketing services, venue rental, and other donated services by professional firms. This brings our expenses to \$164,915.
- Because Bellis adheres to the Heartfelt Connector model (as described by the Stanford Social Innovation Review) as a way to build and nurture a community of volunteers and supporters, a large portion of management and fundraising resources is invested in events that cultivate supporters and volunteers.
- For the current year, we anticipated cash-based contributions at \$115,500 and in-kind services at \$45,448.
 We opted to pull \$10,000 from operating reserves in order to invest in expanded peerbased services as well as an administrative assistant to support all program areas. This brings our total anticipated revenues to \$170,948.

LEADERSHIP TEAM SETS NEW STRATEGIC PRIORITIES

Bellis leadership has worked hard this year to ensure a sound framework for strategic growth. Having successfully met the objectives of our 2015 three-year plan, we worked in May with Strategic Consulting & Coaching in St. Paul to set forth new, exciting goals. These goals include expanding current programs, creating new peersupport opportunities, and finding our own office and meeting space.
